IV. Deaccessioning

The Artist agrees that should OFAM determine at any point in the future that the work(s) donated are inappropriate for retention OFAM may transfer the work via sale or donation without notice to the Artist.

V. Copyright

A. Non-Exclusive Transfer of Rights

The Artist hereby grants and assigns the non-exclusive rights to publish, reproduce, display or perform the donated work. The artist retains copyright ownership as the original author of the work but grants OFAM the right to display the work online or in a physical space and to reproduce the work for publicity, merchandising, and fundraising purposes.

A. Exclusive Transfer of Rights

The Artist hereby grants and assigns all ownership in the copyright of this work to OFAM, including the right to publish, reproduce, display or perform the donated work. These this includes, but it not limited to, the right to display the work online or in a physical space and to reproduce the work for publicity, merchandising, and fundraising purposes.

B. Warranty of Originality

The Artist warrants that the donated work is an original work to which the artist holds exclusive copyright with the exception of any disclaimed material described below.

- b. Severability. If any particular term, covenant, or provision of this agreement is determined to be invalid or unenforceable, the invalidity or unenforceability thereof will not affect the remaining provisions of this agreement, which will nevertheless remain in full force and effect.
- c. **Captions.** Any captions or headings to the sections of this agreement are solely for the convenience of the parties hereto, are not part of this agreement, and are not to be used for the interpretation or determination of the validity hereof.
- d. **No waiver.** No waiver or modification of any of the terms of this agreement will be valid unless in writing. No waiver by either party of a breach hereof or default hereunder will be deemed a waiver by such party of any subsequent breach or default.
- e. **Entire Agreement.** This agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes all pre-existing agreements and understandings between them with respect thereto.
